- Minimum of 1 maximum of 2 elected Staff Governors (4-year term)
- Minimum of 2 maximum of 3 elected Parent Governors (4-year term)
- Headteacher ex officio
- Up to 7 Co-opted Governors (1 year term)
- Maximum length of office for any governor (except Trustee appointed) is 8 years^
